PROCEDURES FOR REGISTRATION OF
RECREATIONAL VEHICLES
FOR OVERNIGHT PARKING IN BULL PEN AREA
(Check out time 11:00 A.M)

The following procedures are intended to provide guidance to facilitate the orderly registration and parking of guest RV's. It also should help insure that those stockholders who plan ahead and make reservations can be assured to have a space in the Bull Pen for their families when they arrive for a visit.

1. Qualify incoming RV's in compliance with Rule #3 a, d and g. Rule 3.a requires that an RV be either owned by a stockholder or sponsored by a Briny resident of whom the visitor is a relative or friend. Rule 3.d allows only modern RV's that have flush toilets. Rule 3.g states that canvas sided RV's will not be permitted.
2. The Briny Breezes stockholder or resident sponsor shall complete the "Application for Recreational Vehicle Overnight Parking" prior to arrival of guests. The person receiving the application shall assign a vacant site with the proper electric service for the RV.
3. During regular office hours (10:00 a.m. to 4:00 p.m., Monday through Friday) in coming RV owners should be referred to the office for registration and coordination with any reservations that may conflict.
4. Registration shall include:
 - a. Completing the application form
 - b. Collection of fees in accordance with Rule 3.b
 - c. Issuance of parking permits with the sponsors unit number
 - d. Dates of arrival and departure
 - e. Providing guidance in obtaining visitor badges for guests (\$25.00 refundable deposit for each badge)
 - f. Providing a copy of Rule # 3

RULE #3 –OVERNIGHT PARKING (BULL PEN)

Briny Breezes Inc. maintains four parallel spaces on the North side of Cordova (the Bull Pen) for the overnight parking of RVs of guests and residents. Sewer, water and electric connections are available.

The following rules apply to overnight parking:

- a) RV parking is for guests or residents of Briny only.
- b) The current rate schedule will apply for stockholders and non-stockholders.
- c) Maximum stay is 14 days, however, at the conclusion of 14 days, an extension may be requested through the Office, not to exceed a total stay of 30 days.
- d) Recreational vehicles must have a flush toilet
- e) No pets are allowed.
- f) The sleeping capacity of the RV is not to be exceeded.
- g) Type of unit allowed will be at the discretion of the management with provisions that the unit has a pleasing appearance, it is a modern RV and all other requirements are met. Canvas-sided RVs or truck campers are not permitted.
